- 3. Eligibility criteria for participation in tender:
 - i) a) Intending tenderers should produce credential of a Same/Similar nature of Work of the minimum value of 60% of the estimated amount put to tender during 3(Threee) years prior to the date of issue of this tender notice. or,
 - ii) Each bidder should have achieved a minimum financial turnover (60% of amount put to tender in any one year during the last five years in the same name and style (Certified by Chartered accountant) and at least 50% of which is from Civil Engineering works.
- iii) GST, Pan Card, Trade license, Professional Tax receipts with current e-Challan for the year of 2022-23, Professional Tax Payment Certificate, Income tax Acknowledgement receipt of last 3 years to be accompanied with the Technical Bid document.
- iv) Registered Unemployed Engineers' Co-operative Societies/Unemployed LabourCo-operative Societies are required to furnish valid Bye Law, Current Audit Report, and Valid latest Clearance Certificate from A.R.C.S. along with other relevant supporting papers.
