Necessary cost of the Earnest Money (EMD) should be remitted through **Demand Draft or Miscellaneous Receipt Form-05 (Matfarakka)** issued from any nationalized bank in favour of the "Pradhan Anantapur Gram Panchayat" scanned copy of which shall have to upload with other necessary documents and EMD as mentioned above should be paid through direct deposit method only to Bank AC NO 5268010001226, BGVB Mahendraganj, Branch, IFSC CODE- PUNBORRBBGB . THE RECEIPT VOUCHER OF PARTICIPATION Charge and EMD shall have to be uploading along with other necessary documents. and also to be documented through e-filing. The original Demand Draft against earnest money (EMD) should be submitted to the Office of the undersigned under sealed cover. The cost of participation charge should be remitted through **Miscellaneous Receipt Form-05 (Matfarakka)** [as per the resolution of AOP meeting held on 18/01/2023] upto from 22.01.2023 TO 30.01.2023 (up to 12.30 hours) the office except holiday of the undersigned and uploading through e-filing. The documents submitted by the bidders should be properly indexed & digitally signed. All other documents to be shown for scrutiny at the office of the undersigned with his acceptance letter of the LOI. Failure to submit the hard copy of EMD with the acceptance letter within the time period prescribed for the purpose may be construed as an attempt to disturb the tendering process and dealt with accordingly legally including black listing of the bidder.

3. Eligibility criteria for participation in tender:

- i) The prospective bidders shall have satisfactorily completed as a prime agency during the last 3 (THREE) years prior to the date of issue of this Notice at least one work of same/similar nature of work under authority of State/Central govt., Central/State Government undertaking/Statutory Bodies and having past credentials (payment) certificate **60% (Sixty percent)** of the estimated amount put to tender.
- ii) Valid P.tax, trade licence, pan card, enrolment certificate, GST registration certificate, Income tax clearance certificate for the last 3 years to be accompanied/scanned with the technical bid documents.
- iii) Registered Unemployed Engineers' Co-operative Societies/Unemployed Labour Co-operative Societies are required to furnish Current Audit Report, along with other relevant supporting papers.
- iv) **Joint Ventures will not be allowed.**
- v) The partnership firm shall furnish the registered partnership deed and the company shall furnish the Article of Association and Memorandum.
- vi) Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, while uploading any tender for and on behalf of such company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of the directors of such company or the partners of such firm, to upload such tender. The power of attorney shall have to be registered in accordance with the provisions of the Registration Act, 1908.
- vii) The tenderer should disclose if there is any pending liable upon of the firm which may have implications on the liquidity of the firm, if they are black-listed by any Govt. dept. /Semi govt. /Autonomous bodies/PSUs etc.
- viii) Tender Form No-2911(ii), NIT & Scan copy of Demand Draft (properly uploaded and Digitally signed)
- ix) Agencies shall have to arrange required land for installation of plant & tools, storing of materials, labour shed etc, at their own cost and responsibility nearest to the work site.

4. No Mobilization Advance and Secured Advance will be allowed.

5. Agencies shall have to arrange required land for installation of plant & machineries, storing of materials, labour shed, laboratory etc, at their own cost and responsibility nearest to the work site

There shall be no provision of Arbitration.

Qualification Criteria:-

The Tender Inviting & Accepting Authority will determine the eligibility of each bidder, the bidders shall have to meet all the minimum criteria regarding:-

a) **Technical Capability comprising of personnel & Equipment.**

b) **Experience**

The eligibility of a bidder will be ascertained on the basis of the attested documents in support of the minimum criteria as mentioned "a & b" above and the declaration executed through a **non-judicial stamp paper** of appropriate value worth Rs. 10.00(Ten) duly self-signed. If any document submitted by a bidder is either manufactured or false, in such cases the eligibility of the bidder/supplier will be out rightly rejected at any state without any prejudice with forfeiture of earnest money forthwith. The bidder should submit self attested Xerox copy of all documents which was submitted through e-filing.

The Pradhan, Anantapur Gram Panchayat reserves the right to reject or cancel any or all pre-qualification documents and tender documents without assigning any reason whatsoever.

9. a) Payment will be made by this office on submission of bill complete in all respects and after due certification from the component authority that supply work has been done satisfactory. any prayer for revision of rate within contract period shall not be entertained .

b) The agreement shall be executed within 7(seven) days from the date of issuance of letter of acceptance (L.O.A)

10. The intending bidders are requested to inspect the proposed work site before quoting their rates.

11. . Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) as performance security in the form of Cash/Cheque/Bank Draft/Government Bond / Securities duly pledged in favour of the Pradhan, Anantapur Gram Panchayat Gram Panchayat OR the amount may be deducted from every running payment (not exceeding two including the final bill) made and will be released after 6 months in all cases except ISGPP Block Grant where it will be released after 6 months in case of Building, Culvert and Concrete Roads and 12 months in all other cases

12.A penalty @ of 0.1% (one percent) of value of the work may be Imposed on per day of delay.


13. joint venture will not be allowed.

The work should be complained within the prescribed time. No extention of time will be allowed in special case if it is found that the delay cause due to such reasons which is beyond the control of the contractor and on the Issue wheather any reasons beyond the control of the contractor , the decision of the under signed shall be final.

16. The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be done without assigning any reasons whatsoever.

17. Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable
