- 1 Bidders must upload self attested photocopies of valid GST registration Certificate, last three years income Tax Return with PAN Card, Profession Tax Registration Certificate with current cheques(2022-23) and Trade Registration Certificate,Income(2022-23).
- 2 Bidders must submit Confidential in similar nature of work in between the last three financial years (i.e. on or after 01/04/2019) of work completion date)
- 3 In case of bidder/contractor emanating from cancellation of bidders, entire tender process will be cancelled
- 4 The bidders will have to show or submit original bid/return after the opening tenders and if stated by the tendering authority
- 5 Rate offered by a bidder in a particular tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed
- 6 No special preferences in regard of Earnest Money Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/Engineering Cooperative etc. In other words all participating bidders will be treated on equal basis only and no special/preference considerations will be accorded to any bidder.
- 7 Participation Charge and EMD : For all bidders required to submit the requisite Participation Charge (non refundable) have to be deposited in A/C No 5242010000031, Bangiya Gramin Vikash Bank, Bahar Branch, IFSC : PUN0000000000 through NEFT/RTGS in favour of the Y MO (YAMAL G P OMS) FUND from 24.01.2023 to 03.02.2023 at 09.00 am to 4.00 pm and updating through e-filing. Necessary cost of the Earnest Money (EMD) should be deposited through DEMAND DRAFT issued from any nationalized bank in favour of the "PRODHAN ITAHAN GRAM PANCHAYAT" and also to be documented through e-filing. The original Demand Draft signed amount money (EMD) should be submitted to the office of the the undersigned in sealed cover on 03.02.2023 at 12.00 noon to 4.00 pm. NIT NO. BSNM/ No. NIT Data, Demand Draft No and Demand Draft amount should be written on the sealed cover.
- 8 Successful Bidder (s) will have to lodge security deposit (10% of the total value of the work as quoted by him) debited from every running payment (not exceeding three including the final bill) made and will be released 6 months in case of Building, Culvert and Concrete Roads and 3 months in all other cases from the date of payment
- 9 GST, ITDS and Labour Cess will be deducted as per existing rates laid by the respective department of the Government
- 10 Site visit may be done by the bidders at their own cost
- 11 Experience or recognizable e- tender will be summarily rejected without accepting any reason whatsoever
- 12 Successful bidder will have to execute a formal contract on a Non-Judicial Stamp paper within seven days from the receipt of 'Letter of Acceptance' with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and EMD (Governmental and Social Management Agreement) shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid
- 13 Quoted rate shall be inclusive of all charges including mostly GST with charges transportation etc.
- 14 Register Partnership Deed in case of partnership firm has to be submitted. The currently valid Form of Incorporation and Memorandum. Where an individual person holds a digital certificate in his own name duly issued to him signed the company or the firm of which he belongs to be a director or partner, such individual person shall where uploading any tender for on behalf of the company or firm invariably upload a copy of register power of attorney/authorizing their authorization in the tender by the use of the director of such company or the partner of such firm to upload such tender (non statutory document)
- 15 Joint venture will not be allowed
- 16 Payment will be made as and when fund is available from the concerned authority. No claim for advance for a bill payment. Only final bill will be paid for this work. Contractors are requested to quote their rate accordingly
- 17 During security if it comes to notice of the tendering authority that the contractor or any other tenderer has not provided necessary information that bidder would not be allowed to participate in the tender and the application will be reject without any prejudice
- 18 The contractor's responsibility to keep the road open to all kind of traffic during the execution of work. No claim would be ever will be entertained for idle labour, establishment cost of hire and labor charges of tools and plants and any unwanted incidence etc. at any circumstances.
- 19 There is the release of contract. The successfully contractor must start the work within seven days from the date of signing of agreement/contract. Bidding which the undersigned may cancelled the work order and contract and forth the earnest money. The work should be completed within the prescribed time. The extension of time will be allowed accepted in special cases if it is found that the delay caused due to such reason which is beyond the control of the contractor and on the issue whether any reason is beyond the control of the contractor, the decision of the undersigned shall be final
- 20 A penalty @ of 1% (One percent) of the value of the work may be imposed on per day of delay
- 21 If during execution of work it is found that the progress of work is very slow and the contractor failed to speed up the work even after repeated reminders and the work is going to be delayed unnecessarily due to fault on the part of the contractor and/or the quality of work is not as per the plan and estimate and the contractor does not make required modification after being so notified, the work order and contract shall be cancelled. The earnest money shall be forfeited. The contractor may be black listed and claim of payment of work already executed before work termination, may not be considered or entertained
- 22 In case of such work termination of the work order and contract at the undersigned may also proceed to get the balance work completed by engaging other contractor's agencies or departmentally. The excess expenditure if any, due to such a stop would be recoverable from the original bills of the defaulting contractor. Claims of such bills has not been verified at the time of termination of work order and contract as mentioned at point no above

Bidder(s) may be asked to submit rate analysis for items where the quoted rate are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the bidder have formed a cartel and rates have been manipulated, unbalanced or unreasonable.

24 Agency submit test report of materials if required - A) Compressive strength of cement B) Grading of sand (sieveanalysis), C) Crushing strength of stone chips

25 The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.

26 Contractor should maintain Covid-19 precaution (Social distance mask sanitizer etc) at work place as per govt norms and no claim will be entertained for such type of expenditure incurred by the contractor.

27 For the successful Bidders if the accepted bid value is 80% or less of the amount put to Tender than the additional performance security @ 10% of Tender Amount shall be deposited in the form of Bank Guarantee from any schedule bank before issuance of the Work Order. If the Bidder fails to submit the additional performance security within 7 working days from the date of issue of Letter of Acceptance, his/her earnest money will be forfeited and other necessary action as per NIT like Black listing of the Constructor etc. may be taken.
