Even after issuing of work order or during work ongoing if the above matters come to the notice of the undersigned, the contract will

If during execution of work it is found that the progress of work is very slow and the contractor failed to speed up the work even after repeated reminders and the work is going to be delayed unnecessarily due to fault on the part of the contractor and/or the quality of work is not as per the plan and estimate and the contract or does not make required rectification after being so instructed, the work order and contract shall be cancelled, the earnest money shall be forfitted, the contractor may be black listed and claim of payment of work already executed before such termination, may not be considered or entertained.
- 18. C. In case of such mid-term termination of the work order and contract, the undersigned may also proceed to get the balance work completed by engaging other contracting agencies or departmentaly. The excess expenditure if any, due to such a step would be recoverable from the unpaid bills of defaulting contractor, if claim of such bills has not been forfitted at the time of termination of work order and
