- 2 Both Technical Bid and Financial Bid will be submitted online concurrently duly digitally signed in the Website http://wbtenders.gov.in as per time schedule stated below.
- 3 The financial offer of the prospective tenderer will be considered only if the tender qualifies in the Technical Bid and the tenderer is found eligible by the Tender Inviting Authority.
- 4 For participating in the Tender, the Tenderer shall have to pay the Earnest Money(EMD) in the form of Online mode only NEFT/RTGS in favour of Own Fund account of Sitgram Gram
- 5 Cost of Participation Charge (Non Refundable) shall have to pay in the form of Online mode only NEFT/RTGS in favour of Own Fund account of Sitgram Gram Panchayat A/C Name:
