7. Only online submission of bids is permitted, therefore; bids must be submitted online on website www.wbtenders.gov.in. The technical qualification part of the bids will be opened online at 16.00 P.M (time) on 29-09-2023 by the authorized officers. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened online on the next working day at the same time.

Estimated amount, Tendered Amount, Actual date of completion of the project and detail address for communication must be indicated in the Credential Certificate.

Credential: Scanned copy of work credential issued in favour of the contractor/bidder as detailed below:

In case of execution of supplementary/substitute supplementary items having values more than 30% of BOQ, final gross value of bill (without contractual rates) including such supplementary/ substitute supplementary items may be considered to ascertain similarity in nature of work and authenticated copy of such bills may be uploaded, if made available and desired by the bidder.
