- 1. Scanned copies of the Deposite Slip/online payment receipt or M.R receipt of the same should be uploaded as Statutory Document / Technical File, failing which the application will be rejected.
- 2. Earnest Money noted against the work as mensioned in ANNEXURE-A is to be submitted in favour of the "Pradhan, Bidyanandapur Gram Panchaya" payable at BGVB ank, Shakuntla, Uttar Dinajpur, West Bengal. Account Number- 5483011002281, IFSC- PUNB0RRBBGB or by cash at the office of the undersigned. Scanned copies of the Deposite Slip/online payment receipt or M.R receipt of the same should be uploaded as Statutory Document / Technical File. Without Earnest Money, bidder's tender will treated as informal and will be rejected. Joint venture will not be allowed.
- 3. Bidders must upload self-attested photocopies of valid GST registration Certificate, last three years Income Tax Return (Assessment Years: 2020-21, 2021-22, 2022-23) with PAN Card, Certificate of Enrollment. Profession Tax current e-challan and Trade Registration Certificate/License from local bodies as the case may be.
- 4. Bidders must submit Credential in similar nature of work as mensioned in ANNEXURE-A.
- 5. In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- 6. Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
- 7. No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders.
- 8. Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him), which will be deducted from the Final bill made and will be released after 6 months in case of Building. Culvert and Concrete Roads and 3 months in all other cases.
- 9 GST, ITDS and Labour Cess will be deducted as per existing rates fixed by the respective department of the Government.

- 13. Quoted rate shall be inclusive of all charges including taxes, royalty, tools charges, transportation etc compiete in all respect.
- 14 Registered Partnership Deed in case of partnership firm has to be submitted. The company shall furnish the Article of Association and Memorandum. Where an individual persion holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual persion shall where uploading any tender for on behalf of the company or firm invariablely upload a copy of registered power of attorney showing clear authorisation in his favour, by the rest of the director of such company or the partner of such firm to upload such tender.( non statutary document.)

- 16 Payment will be made as and when fund is available from the concerned source after fully completion of work. No claim for R.A. Bill payment will be entertained. Only final Bill will be paid for this work. Contractors are requested to quote their rate accordingly.
- 17 During scrutiny if it comes to notice of the tender inviting authority that the credential or any other paper found incorrect/ manufactured/ fabricated, that bidder would not be allowd to participate in the tender and the application will be rejected without any prejudice. Even afetr issuing of work order or during work ongoing if the above matters come to the notice of the undersigned, the contract will cancelled and others respective
- 18 The contractor's responsibility is to keep the road open to all kind of traffic duribng the execution of work. No claim whatsoever will be entertain for idle labour, establishment cost, hire and labor charges of tools and plants and any unwanted incidence etc. at any circumstances.
- 19 Time is the essence of contract. The successful contractor must start the work within seven days from the date of signing of agreement/ contract, failing which the undersigned may cancel the work order and contract and forfit the earnest money. The work should be completed within the prescribed time. - 19 B. If during execution of work it is found that the progress of work is very slow and the contractor failed to speed up the work even after repeated reminders and the work is going to be delayed unnecessarily due to fault on the part of the contractor and/ or the quality of work is not as per the plan and estimate and the contractor does not make required rectification after being so instructed, the work order and contract shall be cancelled, the earnest money shall be forfitted, the contractor may be black listed and claim of payment of work already executed before such termination, may not be considered or entertained.
- 19 C. In case of such mid-term termination of the work order and contract, the undersigned may also proceed to get the balance work completed by engaging other contracting agencies or departmentaly. The excess expenditure if any, due to such a step would be recoverable from the unpaid bills of the defaulting contractor, if claim of such bills has not been forfitted at the time of termination of work order and contract as mentioned at point be above.
- 20 Bidder(s) may be asked to submit rate analysis for items where the quated rate are either below 5% or above than the estimated cost. Such bids may also be considered as null and void if there is a reason to belive that the bidder have formed a cartel and rates have been manupulated, unbalanced or unreasonable.
- 21 Contractor are bound to submit following test report of materials sample collected from the site before execution of work:- A) Compressive strength of cement B) Grading of sand (sieveanalysis), C) Crushing strength of stone chips if asked.
