Scanned copies of the Deposite Slip/online payment receipt or M.R receipt of the same should be uploaded as Statutory Document / Technical File, failing which the application will be rejected.
- 2. Earnest Money noted against the work as mensioned in ANNEXURE-A is to be submitted in favour of the "Pradhan, Bidyanandapur Gram Panchaya" payable at BGVB ank, Shakuntla, Uttar Dinajpur, West Bengal. Account Number- 5483011002281, IFSC- PUNBORRBBGB or by cash at the office of the undersigned. Scanned copies of the Deposite Slip/online payment receipt or M.R receipt of the same should be uploaded as Statutory Document / Technical File. Without Earnest Money, bidder's tender will treated as informal and will be rejected. Joint venture will not be allowed.
- 3. Bidders must upload self-attested photocopies of valid GST registration Certificate, last three years Income Tax Return (Assessment Years: 2020-21, 21-22, 22-23) with PAN Card, Certificate of Enrollment, Profession Tax current e-challan and Trade Registration Certificate/License from local bodies as the case may be.
- 4. Bidders must submit Credential in similar nature of work as mensioned in ANNEXURE-A.
- In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled. 5.
- 6. Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
- 7. No special preferences in respect of Earnest Money. - 17 During scrutiny if it comes to notice of the tender inviting authority that the credential or any other paper found incorrect/ manufactured/ fabricated, that bidder would not be allowd to participate in the tender and the application will be rejected without any prejudice. Even afetr issuing of work order or during work ongoing if the above matters come to the notice of the undersigned, the contract will cancelled and others respective action will be applied.
- 18 The contractor's responsibility is to keep the road open to all kind of traffic duribng the execution of work. No claim whatsoever will be entertain for idle labour, establishment cost, hire and labor charges of tools and plants and any unwanted incidence etc. at any circumstances.
- 19 Time is the essence of contract. The successful contractor must start the work within seven days from the date of signing of agreement/ contract, failing which the undersigned may cancel the work order and contract and forfit the earnest money. The work should be completed within the prescribed time. No extention of time will be allowed except in special cases if it is found that the delay caused due to such reason which is beyond the controll of the contractor. the decision of the undersigned shall be final.
